*An additional time payment fee of \$15 will be assessed if any part of a fine, court costs, or restitution is paid on or after the 31st day after the date the judgment assessing the fine, court costs or restitution is entered, pursuant to Texas Local Government Code, Section 133.103.

*An additional \$2.00 transaction fee will be assessed on each payment toward the fine, restitution and court costs that are assessed pursuant to Texas Code of Criminal Procedure, Article 102.072.

*An additional collection fee of 30% of the amount of any fine, court costs and restitution that is ordered to be paid and is more than 60 days past due will also be assessed pursuant to Code of Criminal Procedure, Art. 103.0031.
