

### VICTORIA COUNTY EMPLOYEE MEMBERSHIP FEES

Enrollment Fee	\$0 - waived
Monthly Individual (Payroll Deduction Required)	\$32.50
Monthly Spouse (Payroll Deduction Required)	\$32.50
Monthly Child*	\$32.50

\*Must be 16 yrs of age to use facility. Child add-on rate applies for children 16-21 yrs of age. Payment information for automatic withdrawal must be provided at time of enrollment.

\*\*Employee must be a member for their spouse or child to receive discount.

### **Eligible Employees**

- Employees, Spouses and Children ages 18 through 21  
(Regular Full-time and Part-time employees are eligible for membership.  
Membership is not open to temporary or seasonal employees.)

### **Enrollment Fee**

- Waived for all mentioned above

### **Membership Dues**

- Employee \$32.50 monthly  
**Payroll deducted twice monthly at \$16.25 per pay date**
- Employee and Spouse: \$65 monthly  
**Payroll deducted twice monthly at \$32.50 per pay date**
- Children: \$32.50 monthly  
**Drafted monthly from personal credit card or checking/savings account**

### **Attendance Requirements**

- None
- County Policy encouraging 8 visits per month for rebate of employee only membership dues.

### **Details and Reminders**

- No annual memberships
- Employee and Spouse dues **must** be payroll deducted.
- Children's dues must be drafted monthly from personal credit card or checking/savings account.
- Deli, pro shop, child care, massage and personal training purchases are at the expense of the employee.
- No need to get drafting unless they are adding a dependent or want Charge to Account, or Kids in Motion.
- Spouse proof is required by County for spousal deduction
- You are responsible as an employee of Victoria County of notifying the Healthplex 30 days prior to cancellation of membership.



## VICTORIA COUNTY REDUCED & NO COST GYM BENEFIT POLICY

1. **Purpose:** The purpose of this policy is to encourage employees to maintain a healthy and active lifestyle by providing a gym utilization benefit for waived/reimbursed membership costs. *This policy is only applicable to the utilization of Citizens HealthPlex.*
2. **Eligibility:** All regular full-time and regular part-time employees of Victoria County. *This policy excludes temporary employees and adult probation.*
3. **Gym Membership:** Employees must sign up for gym membership through the existing designated process outlined by the Victoria County HR department.
4. **Gym Utilization:**
  - a. This benefit is to be utilized in conjunction with the existing half-off gym membership benefit.
  - b. To qualify for waived/reimbursed fees in the upcoming month, employees are required to use the gym a minimum of 8 times during the current month.
  - c. Multiple scans per day are not allowed and will only be calculated as 1 visit.
  - d. It is the responsibility of the employees to ensure their attendance is accurately recorded at Citizens HealthPlex.
  - e. If the employee does not reach the minimum requirement of 8 times a month, fees will not be waived/reimbursed.
5. **Modifications to Policy:** Victoria County Commissioners Court reserves the right to modify or terminate the Employee Reduced & No Cost Gym Benefit Policy at its discretion.
