

# County of Victoria Development & Permit Guidelines

## **General Permit Information:**

The County of Victoria has not adopted a Zoning Ordinance/Minute Order for the county.

ETJ Division of Property: An Interlocal agreement between the City of Victoria and the County of Victoria states any property within the ETJ (Extra Territorial Jurisdiction) must follow the City's Development Services department processes & procedures. #### **Building Permits:**

The County of Victoria has not adopted building codes for development (residential or commercial) in the unincorporated area of the County.

The County of Victoria does not issue building permits or provide a certificate of occupancy.

# <u>On-Site Sewer Facilities (OSSF – Septic Systems), Floodplain Permits and Storm Water</u> <u>Management Program:</u>

OSSF, Floodplain and Storm Water Management permits are reviewed, issued, inspected and approved by the Environmental Services Division of the Victoria County Health Department.

#### **General Drainage Regulations:**

Texas State Law:

Texas Water Code: Title 2 - Water Administration; Subtitle B - Water Rights; Chapter 11 - Water Rights; Subchapter A - General Provisions;

Section 11.086 – Overflow Caused by Diversion of Water:

- (a) No person may divert or impound the natural flow of surface waters in this state, or permit a diversion or impounding by him to continue, in a manner that damages the property of another by the overflow of the water diverted or impounded.
- (b) A person whose property is injured by an overflow of water caused by an unlawful diversion or impounding has remedies at law and in equity and may recover damages occasioned by the overflow.
- (c) The prohibition of Subsection (a) of this section does not in any way affect the construction and maintenance of levees and other improvements to control floods, overflows, and freshets in rivers, creeks, and streams or the construction of canals for conveying water for irrigation or other purposes authorized by this code. However, this subsection does not authorize any person to construct a canal, lateral canal, or ditch that obstructs a river, creek, bayou, gully, slough, ditch, or other well-defined natural drainage.
- (d) Where gullies or sloughs have cut away or intersected the banks of a river or creek to allow floodwaters from the river or creek to overflow the land nearby, the owner of the flooded land may fill the mouth of the gullies or sloughs up to the

height of the adjoining banks of the river or creek without liability to other property owners.

#### Division of property or subdivision of property:

<u>Unincorporated Area of Victoria County outside the City of Victoria's Extra Territorial</u>
<u>Jurisdiction (ETJ):</u>

Division of property in the unincorporated areas of Victoria County into lots <u>10 acres</u> <u>and smaller</u> tracts require platting in compliance with the Texas Local Government Code Chapter 232 and the Victoria County Development Standards.
